

## **ASTROBRIGHTS® Brightest Teacher Contest Rules**

Neenah Paper, Inc. (“Neenah”) invites you to enter its ASTROBRIGHTS® Contest (the “Contest”) by nominating a deserving teacher for a classroom makeover. You must read and agree to the following rules, terms and conditions (the “Contest Rules”) before nominating a teacher. Completion of the nomination form will be deemed an acceptance of the Rules.

The Contest is open to ALL individuals at least 18 years of age, except employees of Neenah and the immediate families of such employees. To be eligible for nomination, a teacher must be employed as a full time teacher in any public or private school in the Continental United States of America.

### **How to Enter**

Each nomination must be submitted electronically by visiting the website [www.colorizeyourclassroom.com](http://www.colorizeyourclassroom.com) (“Web Site”) during the Contest Period and following the instructions to complete and submit the teacher nomination. For your nomination to be valid, you must complete all required information. The nomination should include the following information:

- Your Name (First, Last)
- Your Email
- Your relation to nominee
- Nominee’s name (first, last)
- Grade level currently teacher
- School currently teaching
- The Nominated Teacher’s email (This is how we will reach out to the winning teacher)
- Why your nominee deserves to be the Brightest Teacher of the Year (200 words or less). We are looking for a teacher who brightens those around him/her. Someone who goes above and beyond their job to inspire others.

Individual teachers may be nominated more than one time, but multiple nominations will not increase the odds of winning.

### **Eligibility and Judging**

To ensure eligibility for the contest, nominations must include all of the information listed above. Nominations that do not meet this standard may or may not be judged at the judging panel's sole discretion.

All of the nominations will be judged by the online voting process detailed on the website. The judges will include Neenah’s Bright Mind Ambassadors and Neenah employees. The judges will select the winners in each category and one overall winner. Judging of the nominations and the

selection of the Grand Prize Winner will be determined in Neenah's sole discretion. Neenah shall determine the Grand Prize Winner's eligibility in its sole and absolute discretion. All decisions made by the judges are final.

### **Deadline**

Online entries can be uploaded starting 12:01 am Eastern Standard Time on February 14, 2017. Deadline for submitting entries is 11:59 pm Eastern Standard Time on March 26, 2017.
